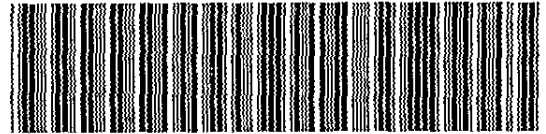

PURSUANT TO CHAPTER 48.091, FLORIDA STATUTES, IVAN G. 
