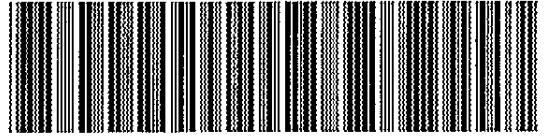



ARTICLES OF INCORPORATION

OF


