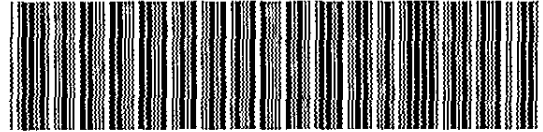

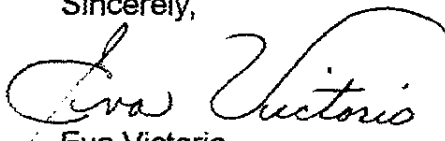

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be PULSE MEDICAL SUPPLIES, INC. The principal place of business of this corporation shall be 11300 49th Street North, Clearwater, FL 33762.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having ten cents (\$0.10) par value per share.

ARTICLE IV. ADDRESS

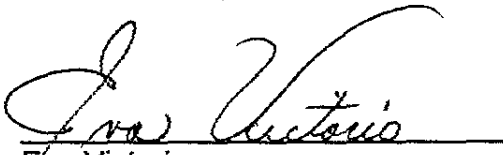

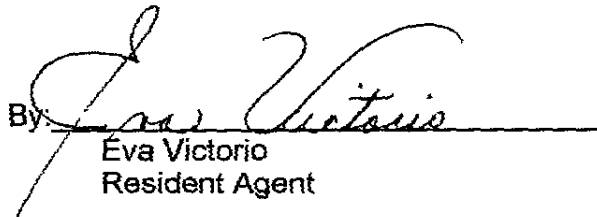
