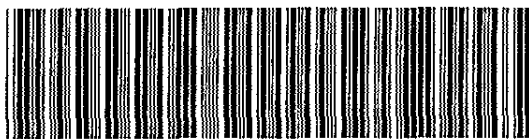



**ARTICLES OF INCORPORATION
OF

Article I - Name

The name of the Corporation is Tio Corporation.

Article II - Duration

The Corporation has perpetual existence.

Article III - Purpose

The Corporation is organized for the purpose of transacting any and all lawful business.

Article IV - Address

The principal place of business or mailing address of the Corporation is:

Boca Raton, FL 33498

Article V - Capital Stock

The Corporation is authorized to issue 1,000 shares of \$0.001 par value common stock.

Article VI - Preemptive Rights

Each shareholder of the Corporation has the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the price for which it is offered to others, each shareholder's *pro rata* portion any newly-issued shares of the same class owned by each shareholder. This right is deemed waived by a shareholder who does not exercise it and pay for the shares preempted for 30 days after receipt of written notice from the Corporation stating the price, terms and conditions of the issue of shares and inviting the shareholder to exercise this preemptive right. This right may also be waived by a written waiver signed by the shareholder.

Article VII - Initial Registered Office and Agent

Article VIII - Initial Board of Directors

Article X - Powers

The Corporation has all of the corporate powers enumerated in the Florida Business Corporation Act.

Article XI - Indemnification

Provided the person proposed to be indemnified satisfies the requisite standard of conduct for permissive indemnification by a corporation as specifically set forth in the applicable provisions of the Florida Business Corporation Act [currently, Subsections 607.0850 (1) and (2) of the Florida Statutes], as the same may be amended from time to time, the Corporation shall indemnify its officers and directors and may indemnify employees and agents, from and against any and all of the expenses and liabilities incurred in defending a civil or criminal proceeding, or other matters referred to in or covered by said provisions, including advancement of expenses prior to the final disposition of such proceedings and amounts paid in settlement of such proceedings, both as to action in their official capacity and as to action in another capacity while holding such office. The

indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any bylaw, agreement, vote of shareholders or disinterested directors or otherwise. The indemnification provided herein shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs, executors and administrators of such a person, and an adjudication of liability shall not affect the right to indemnification for those indemnified.


Article XII - Amendment
