

The undersigned, for the purpose of forming a for-profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

Article I. Name

The name of this Corporation shall be: Heaven Sent Fashions and Accessories, Inc. (hereafter call the "Corporation").

Article II. Principal Office and Mailing Address

The aggregate number of shares that the corporation is authorized to issue is 100,000. Such shares shall be a single class, and shall be a par value of \$1.00 per share.


