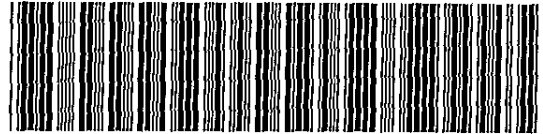

ARTICLE I-NAME

The name of this corporation is Stonegate Enterprises, Inc. and its mailing address is P. O. Box 341464, Tampa, Florida 33694-1464.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE


