The undersigned, Fred H. Goldman, President of Low Carb Ideas, Inc., a Florida corporation (the "Corporation") whose Articles of Incorporation were filed on September 19, 2003 and registered under document number P03000103271, hereby certifies:

1. The name of the Corporation is Low Carb Ideas, Inc.
2. The first sentence of Article I is hereby deleted in its entirety and a new first sentence is inserted in its place as follows:

The name of the corporation is Frat Candies, Inc.

3. Except as above amended, the Articles of Incorporation of the Corporation, as filed with the Florida Department of State on September 19, 2003 shall remain in full force and effect.
4. The foregoing amendment was unanimously approved by the sole shareholder and sole director of the Corporation eligible to vote by a written consent signed by him on April 7, 2004, manifesting his intention that the amendment be adopted, pursuant to Section 607.1003 of the Florida Statutes. The number of votes cast for said amendment was sufficient for approval.
