Conflict of Interest

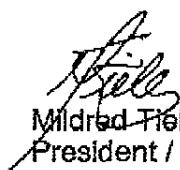

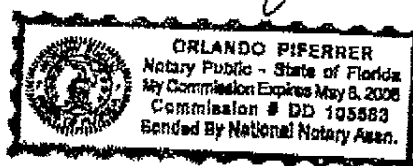
