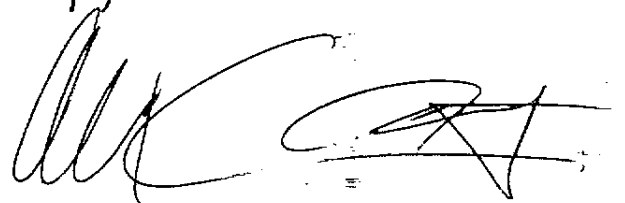

**ARTICLE OF INCORPORATION
OF
LEX THE DETAILER AND ASSOCIATES, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

LEX THE DETAILER AND ASSOCIATES, INC.

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activities or business permitted under the laws of the United States and of the State of Florida.

The activities may include, but not be limited to automobile detailing, repairs and maintenance.

To market, contract and/or transact automobile business of any kind. To buy, sell, trade and generally deal in automobiles and related products.

To engage in import and export of automobiles, parts and any other commodities related to automotive repairs and maintenance.

The corporation may also engage in business management, consultation, support services and any other activities related to automotive industry.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time shall be as follows: One Thousand (1,000) shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be as fixed by the Board of Directors, and may take the form of services rendered, cash, property, or any other form deemed satisfactory by the Board of Directors.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin business shall not be less than Five Hundred Dollars (\$500.00).

ARTICLE V. TERM OF EXISTENCE

The corporation is to exist perpetually.

ARTICLE VI. ADDRESS

The initial street address of the principal office of the corporation in the State of Florida shall be: 6649 Doubletrace Lane, Orlando, FL, 32819

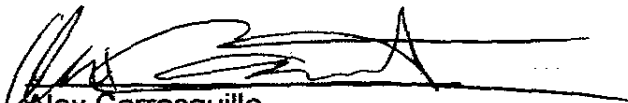
