The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit, under the laws of State of Florida.

**ARTICLE I. NAME**

The name of this Corporation is PLEKO, INC.

The general character, purpose, and nature of the business to be transacted by this Corporation is any lawful business in the State of Florida, including transmission sales and service.

The initial street address and mailing address of the principal office of this Corporation is to be at 2456 Blanding Blvd., Middleburg, Florida 32068.

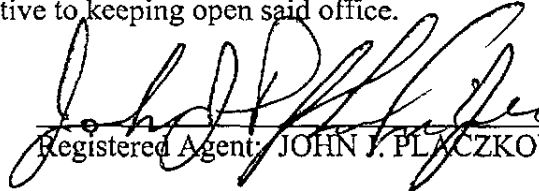
**ARTICLE VI. REGISTERED AGENT/REGISTERED OFFICE.**

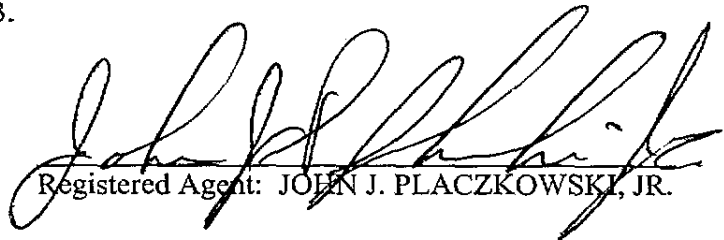

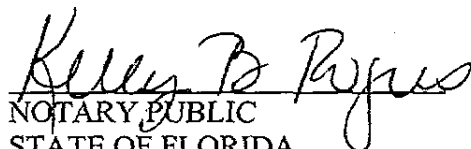
