

OF

ARTICLE I - NAME

The name of this Corporation shall be:
Matthew Orr, P.A.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 09/15/03.

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT




