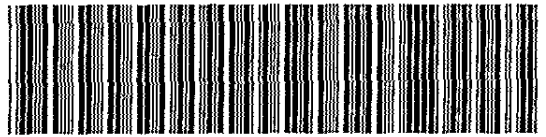

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: **COAST TO COAST MORTGAGE SERVICES, INC.**

ARTICLE II: PRINCIPAL OFFICE

This corporation shall exist perpetually commencing on September 16, 2003.
