Articles of Incorporation Of Fountain Court Restaurant, Inc.

The undersigned, acting as an incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article I

The name of the corporation is Fountain Court Restaurant, Inc.

Article II

The period of duration of the corporation is perpetual.

Article III

The corporation is organized to engage in preparation and service of food and related items and/or any other business permitted by Florida business statutes and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental or connected with said purposes that are not forbidden by the Florida corporation laws or by other law, or by these articles of incorporation, and to carry out said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

Article IV

<u>Authorized Shares.</u> The aggregate number of shares that the corporation shall have the authority to issue is 1,000 shares of Capital Stock with no par value.
