

ARTICLES OF INCORPORATION FOR SECRETARY OF STATE STATE

By these Articles of Incorporation the undersigned incorporator, a natural person competent to contract, and who is licensed or otherwise legally authorized to render the professional services of an Attorney At Law in the State of Florida, associates herself to form a professional services corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I NAME

The name of the Professional Association is LAW OFFICE OF MARGARET E. MARTINEK, P.A.

ARTICLE II PRINCIPAL OFFICE

If the Florida Business Corporation Act is amended to further limit or eliminate liability of a director, then a director of the corporation shall not be liable for any such act or omission to the fullest extent permitted by the Florida Business Corporation Act, as so amended.
