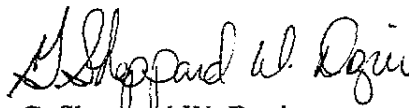

**ARTICLES OF INCORPORATION**  
**OF**

**ARTICLE I**  
Name and Principal Office

The name of this corporation is NORTH CENTRAL COMMUNICATIONS, INC. The principal place of business and mailing address of this corporation is 13 Northeast First Avenue, Ocala, FL 34470.

**ARTICLE II**  
Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

**ARTICLE III**  
Purpose

This corporation is organized for the purpose of transacting any and all lawful business, except that this corporation is not authorized to engage in the business of banking, insurance or engineering.

**ARTICLE IV**  
Capital Stock

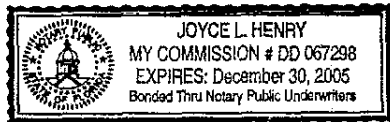
