ARTICLES OF INCORPORATION

ARTICLE I. - CORPORATE NAME

The name of this corporation is:

JESUS DURAN, P.A.

ARTICLE II. - NATURE OF BUSINESS AND FOWERS

This Corporation is organized for the following purposes:

- a. To engage in the practice of Real Estate, and to carry on services incident thereto.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
