The undersigned President, for the purpose of amending the Electronic Articles of Incorporation of the corporation, does hereby adopt the following Amendments to Articles:

ARTICLE III

The general purposes for which the corporation is organized are:

- (1) To provide consulting and accounting services.
- (2) To conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended. Provided, however, and notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition business.

ARTICLE V

The street address of the registered office of this corporation in the State of Florida is 2402 Woodbine Drive, Crestview, Florida 32536. The name of the registered agent for the corporation at that address is Donna B. Fowler.

ARTICLE VIII

The power to adopt, alter, amend, or repeal bylaws of this corporation shall be vested in the Board of Directors and the shareholders.

## ARTICLE IX

The corporation reserves the right to amend or repeal any provisions contained in the Articles of Incorporation or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.
