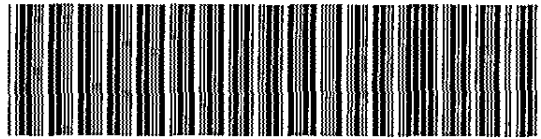

ARTICLE I - NAME

The name of this corporation is Olga C. Rogers, P.A.

ARTICLE II - PRINCIPAL OFFICE
