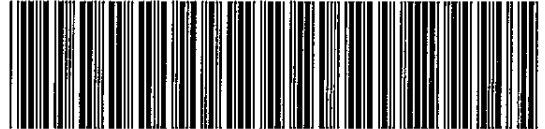

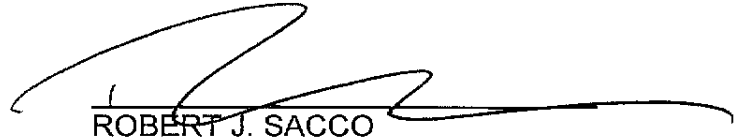
#### **ARTICLE VII – AUTHORIZED SHARES**

**ARTICLE VIII – AMENDMENT**

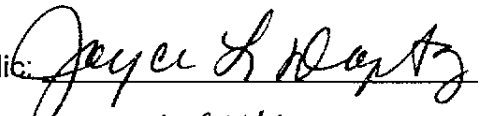

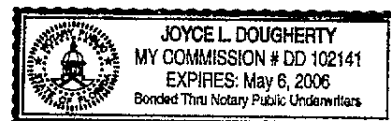

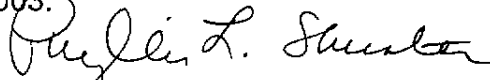
