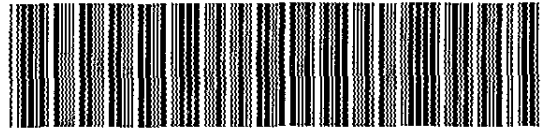

The name of this corporation is First Team Automotive Services, Inc.




