The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Pink Cloud Holdings, Inc. and its address is Suite 303, 3191 Coral Way, Miami, FL 33145.

ARTICLE II

DURATION

The duration of the corporation is perpetual.
