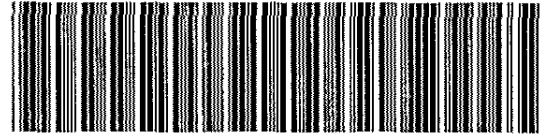

(The word "Gold" has been re-added to the corporate name).

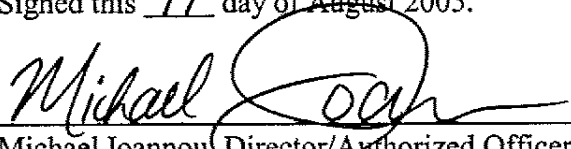
