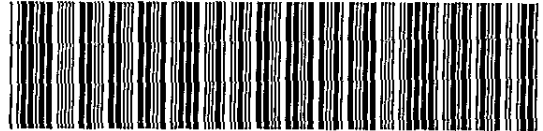

Name of Corporation**

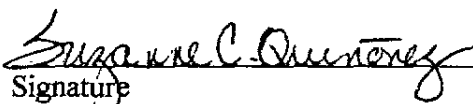

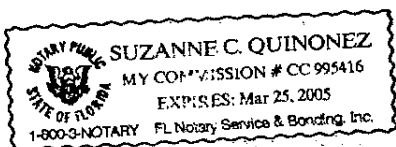

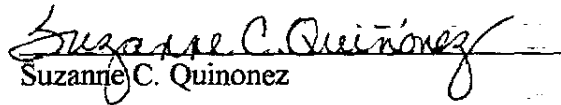
