ARTICLES OF INCORPORATION

OF

MUIR INDUSTRIES, INC.

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Muir Industries, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on September 23, 2003 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:


ARTICLE VIII - SHAREHOLDER PROPERTY

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.


