ARTICLES OF INCORPORATION

COGNITRONE, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is COGNITRONE, INC. and the principal place of business is 2825 University Drive, Suite 350, Coral Springs, Florida 33065

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

- 1. The maximum number of shares of stock which this comporation is authorized to have outstanding at any time shall be Five Hundred (500) shares of common stock having a par value of One (\$1.00) Dollar per share.
- 2. The capital stock may be paid for by the property, labor or services, at a just valuation to be fixed by the incorporators or by the Directors at a meeting called for such purpose, or at the organization meeting.
 - Property, labor or services may also be purchased or

paid for with the capital stock at a just valuation of Baid property, labor or services, to be fixed by the Directors of the company. Stock in other corporations or going businesses may be purchased by the corporation in return for the issuance of its capital stock, and said purchase shall be on such basis and for such consideration and the issuance of so much of the capital stock as the Directors of the company may decide.

ARTICLE Y

The amount of capital with which this corporation will begin business shall not be less than Five Hundred and 00/100 (\$500.00) Dollars.

ARTICLE VI

The street address of the initial registered office of this corporation is 2825 University Drive, Suite 350, Coral Springs, Florida 33065 and the name of the initial Registered Agent of this corporation at 2825 University Drive, Suite 350, Coral Springs, Florida 33065 is Mayer Gattegno, Esquire. The Registered Agent and Registered Office may be changed from time to time by filing with the Secretary of State of Florida, a Cortificate designating a new Registered Agent and/or a new registered office without the necessity of amending these Articles of Incorporation.

ARTICLE VII

The business of the corporation shall be managed by a Board of Directors consisting of not less than one (1) person.

ARTICLE VIII

The number of Directors constituting the initial Board of Directors of the corporation is three (3). The number of Directors may be either increased or diminished from time to time by the By-Lews but shall never be less than one (1). The name and address of each of the members of the initial Board of Directors, who unless otherwise provided by the By-Laws of the corporation, shall hold office for the first year of existence of the corporation or until successors are elected or appointed and have duly qualified are as follows:

The corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law.

ARTICLE_XI

The stockholders of this corporation may divide themselves into groups for the purpose of obtaining unit control in the corporation; and when any agreement is made between stockholders owning at least eighty (80%) percent of the stock then outstanding in the corporation, such agreement shall be binding upon the corporation; and particularly, the stockholders are suthorized to include in such agreement entered into between themselves provisions which will confer upon individual groups of power to elect cextain numbers of directors, and in particular, stockholders may include in the agreement between themselves the following as valid matters of agreement, to-wit:

- The manner and method in which and the persons by whom directors may be elected.
- 2. Any limitation upon the transferability or assignment of the stock.
- 3. The conferring of preemptive rights of purchase upon the stockholders as conditions precedent to the sale of any other stock.
- 4. Any matter related to effectuating the purposes included in any of the foregoing matters.

Agreements between the stockholders shall continue to be binding upon the corporation until there is filed with the President and the secretary of the corporation, in duplicate, a written instrument, signed by the persons who originally created such stockholder's Agreements (or their successor in ownership, providing such succession in ownership shall have been accomplished in accordance with the terms of the Stockholder's Agreements) consenting to the revocation and cancellation of the Agreements among the Stockholders.
