1. Luis Gil is the Vice President of REPRESENTACIONES DELTA 2000 INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on October 1, 2004.
3. That the Corporation failed to file its 2004, 2005 and 2006 Annual Report or pay the 2004, 2005, and 2006 Annual Report filing fees within the time prescribed by Florida Statutes Chapter 607 because:
 - 3.1 the written notice and requirements for filing the Annual Report and pay the Annual Report fee to the Florida Department of State was never received by the Corporation; and,
 - 3.2 the written notice was never received by the Corporation or its Registered Agent that the Florida Department of State was commencing a procedure to administratively dissolve the Corporation.
4. The Corporation requests the Florida Department of State reinstate the Corporation upon the payment by the Corporation of its 2004, 2005 and 2006 Annual Report fees and the filing of its 2004, 2005 and 2006 Annual Reports, which are presented simultaneously with this Affidavit.

6. No further ground or grounds exist for the administrative dissolution of the Corporation.

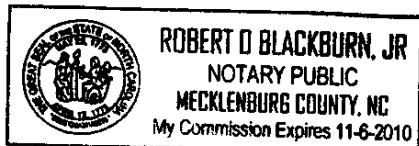
