ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is TERRY L. VIRTÀ & ASSOCIATES INC.

Mary R. McKinney: Vice-President, & Treasurer


ARTICLE X - AMENDMENT


