ARTICLE VI

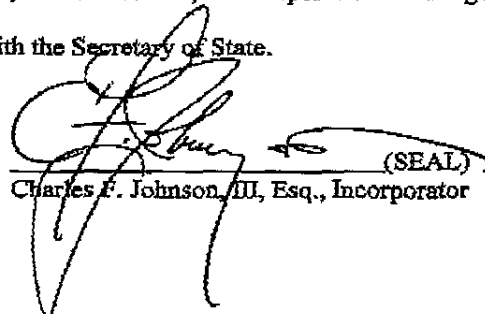
