This is the second time we are sending the complete corporation forms required for the renewal.

The first time we received a notification that the annual report we sent was missing information was on early May. We replayed sending the document with the FEI number stated in the form. *5624 34707 (EIN)*.

(Even though when we filled for the annual report we had marked the box stating that we had applied for the FEI number which was then an allowed option). We submitted this letter via certified mail.

Just this month WITHOUT any previous notification we received a postcard from your Department specifying that our corporation had been dissolved.

There was no prior notification neither an explanation as of why our annual report was rejected again.

We called your department to find out what has happened and the advisor told us that we missed to fill out the name of the officer even though the registered agent and the officer are one and the same with the same mailing address as the corporation itself. However, we did not receive any letter notifying us that we needed to correct that and resend the form once again. The advisor notified us of this last resort and also explained you're your department still have the \$150 check to be applied to our renewal.

We are a small business trying to get ahead. We are pleading with you to please reinstate our corporation since this has not been an oversight in our part but a problem with missing mail, probably due to the weather problems we had to experience in Florida this last season.
