**ARTICLES OF INCORPORATION
OF
AQUI SI CORP.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: **AQUI SI CORP.**

ARTICLE TWO

The term of existence of the corporation is perpetual.

ARTICLE THREE

The purposes for which the corporation is organized are:

To erect, construct, establish, purchase, lease, franchise, and otherwise acquire, and to hold, use, equip, outfit, supply, service, maintain, operate, sell, and otherwise dispose of restaurants, inns, taverns, cafes, cafeterias, grills, sandwich shops, buffets, diners, delicatessens, coffee shops, luncheonettes, ice cream parlors, soda fountains, bakeries, kitchens, bars, saloons, cocktail lounges, banquet halls, catering establishments, concessions, franchises and other eating and drinking places and establishment of every kind and description; and to render all services, and to buy, sell, use, handle, and deal in all fixtures, machinery, apparatus, equipment accessories, tools materials, products and merchandise incidental to related thereto, or of use therein.

To engage in the transaction of any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation has authority to issue is 1,000, all of which shall be common shares with par value of \$1.00.
