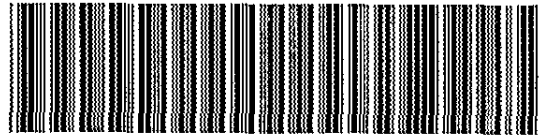

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: Southern Fabricare, Inc.

ARTICLE II. PURPOSE

The purpose for which this Corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

ARTICLE III. INITIAL BUSINESS

The corporation is organized to engage in the service of selling and/or rental of linens to food service establishments and related activities and in any other activity or business permitted under the laws of the United States and Florida.

ARTICLE IV. AUTHORIZED CAPITAL

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$ 1.00 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgement of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE V. REGISTERED AGENT

ARTICLE VI. BOARD OF DIRECTORS

The initial Board of Directors shall consist of two (2) directors. The persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are: Kenneth L. Miley, 4086 Riverwood Road, Tallahassee, Fl. 32303 as President; and Rebecca Jill Miley, 4086 Riverwood Road Tallahassee, Fl. 32303 as Secretary/Treasurer otherwise, the number of persons to serve on the Board of Directors shall be fixed by the Bylaws of the Corporation.

ARTICLE VII. INCORPORATORS

The name and address of the incorporator of the Corporation is: Rebecca Jill Miley, 4086 Riverwood Road, Tallahassee, Fl. 32303.

ARTICLE VIII. DISTRIBUTION FROM CAPITAL SURPLUS

The Board of Directors of the Corporation may, from time to time, distribute to its shareholders out of, or purchase its own shares from, the capital surplus of the corporation.

ARTICLE IX. REPURCHASE OF SHARES

The Board of Directors of the Corporation may, from time to time, cause the Corporation to purchase its own shares to the extent of the unreserved and unrestricted earned and capital surplus of the Corporation.

ARTICLE X. DIVIDENDS

The Board of Directors may authorize the payment of dividends to the holders of shares of stock payable in shares.

**ARTICLE XI INDEMNIFICATION OF OFFICERS, DIRECTORS,
EMPLOYEES AND AGENTS:**

The corporation may indemnify officers, directors, employees or agents in accordance with applicable sections of the state statutes or any successor statute.

ARTICLE XII. LIMITATION OF LIABILITY

The liability of directors to the Corporation or its shareholders for monetary damages for breach of fiduciary duty is eliminated and or limited to the full extent permitted by law.
