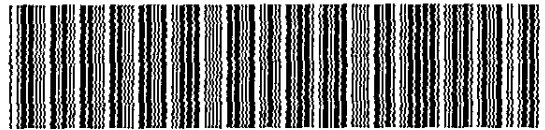

**ARTICLE VI - INITIAL REGISTERED AGENT AND STREET ADDRESS**





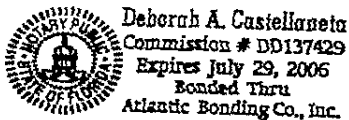
