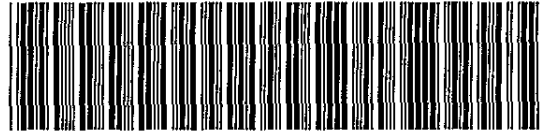

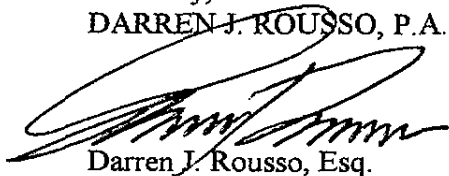

4. The principal office of the Corporation shall be 405 North Hibiscus Drive, Suite 107, Miami Beach, Florida 33139.

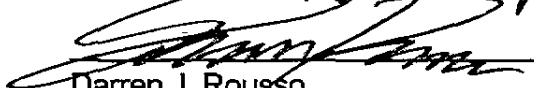

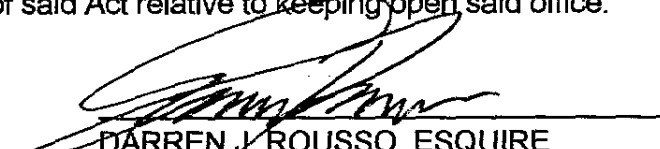
