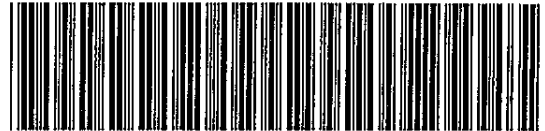

**ARTICLES OF INCORPORATION
OF
N. BURTON WILLIAMS, P.A.**

The undersigned, for purposes of forming a corporation under the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the Corporation shall be N. BURTON WILLIAMS, P.A.

ARTICLE TWO

This Corporation shall have perpetual existence.

ARTICLE THREE

This Corporation is formed for the purpose of conducting a legal practice and to do such other things as are incidental, necessary or desirable in order to accomplish such lawful business.

ARTICLE FOUR

The maximum number of shares of stock that this corporation shall be authorized to have outstanding at any time shall be One Thousand (1,000) Shares of common stock, of the par value of One (\$1.00) Dollar per share.

ARTICLE FIVE

Every stockholder shall, on the sale for cash, of any new stock or authorized, but unissued, stock or treasury shares of the same class as that which (he) (she) already holds, have the right to purchase (his) (her) pro rata share thereof (as nearly as may be done without issuance of fractional shares), at the price and upon the terms such stock is offered to others.

ARTICLE SIX

The principal place of business of the Corporation shall be located at 324 South Hyde Park Avenue, Suite 375, Tampa, Florida 33606. N. Burton Williams shall be the Registered Agent for the Corporation at said address.

ARTICLE SEVEN

Initially the corporation shall have one (1) director. The number of directors may be increased or decreased from time to time as reflected in the By-Laws, but shall never be less than one (1). The name and address of the initial director is:

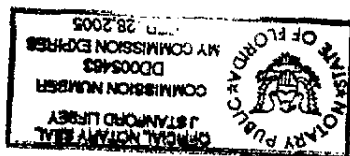


