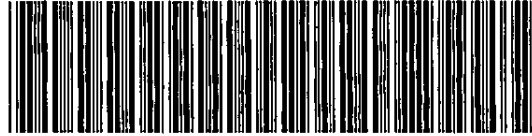

**Landrum Staffing Services, Inc. II**

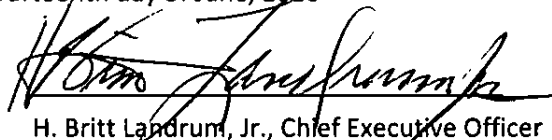
effective June 1, 2016.
