

ARTICLES OF INCORPORATION

OF

SEBRING 7'S, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

- Article 1. NAME. The name of the corporation is: SEBRING 7'S, INC.
- Article 2. DURATION. The duration of the corporation is perpetual.
- Article 3. PURPOSE. The purpose for which the corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. 
