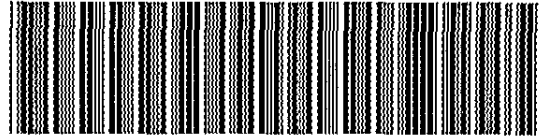

ARTICLES OF INCORPORATION OF
SURJIT AND SONS, INC.

IN COMPLIANCE WITH CHAPTER 607 AND/OR CHAPTER 621, F.S.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the State of Florida.

1. ARTICLE I Name.

The name of the corporation shall be:

SURJIT AND SONS, INC.,

2. ARTICLE II PRINCIPAL OFFICE

3. ARTICLE III PURPOSE

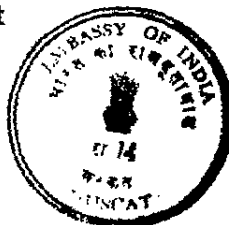

