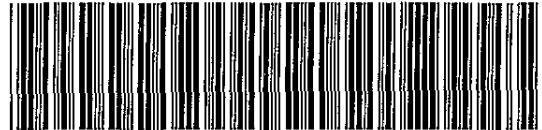

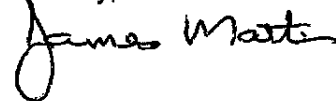

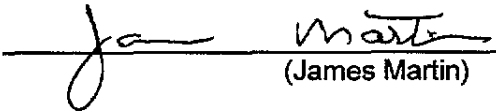
ARTICLE FIVE

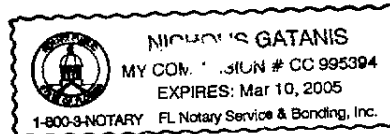
