undersigned, acting as incorporator of a Corporation pursuant to Chapter 607, Florida Statutes, adopt (s) the following Articles of Incorporation of such corporation:

## ARTICLE I - NAME AND PLACE OF BUSINESS

#### ARTICLE II - TERM OF EXISTENCE

The period of the duration of this Corporation is perpetual unless dissolved according to law.
