**ARTICLE I - NAME**

The name of this corporation is FULL CIRCLE EXTERIORS, INC. The principal address of said corporation is 5550 SE 43<sup>rd</sup> Court, Ocala, FL 34480.

This Section is intended to expand the ability of the corporation to conduct business with interested parties and shall not be construed to invalidate any contract or other transaction that would otherwise be valid under the common and statutory law applicable to it.

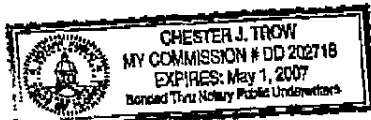
