The information contained in this report correctly states the names, addresses, and titles of the officers, directors, and registered agent. On June 24, 2014, a 2014 Florida Profit Corporation Amended Annual Report was wrongfully and erroneously filed by some unknown person who had no authority to do so. This report falsely states the name and address of the officers, directors and registered agent. The person filing this report identified himself as "Thomas Brannon" by electronic signature. No person with this name has ever been affiliated in any way with Brannon's Paint Contracting, Inc. At the time the wrong and erroneous Amended Annual Report was filed the contact email address was also changed to an email address unknown to Brannon's Paint Contracting, Inc. As a result, Brannon's Paint Contracting, Inc. received no communication concerning the corporation or its status from the Department of State after June 24, 2014.
