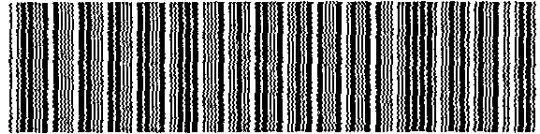

ARTICLE I. NAME

NAME: The name of this corporation is BROWN SPOTS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 25th day  
of September, 2003.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of participating in radio or media advertising, specifically in the creation of audio production services for clients, and for all other purposes allowed according to the laws of the State of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common stock.

ARTICLE V. PREEMPTIVE RIGHTS




