# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SPOTO'S OAKWOOD GRILL PGA INC a Florida corporation

Pursuant to the provisions of section 607.1006, Florida Statutes, SPOTO'S OAKWOOD GRILL PGA INC. adopts the following amendments to its Articles of Incorporation:

FIRST: The name of the corporation is SPOTO'S OAKWOOD GRILL PGA. INC. (the "Corporation").

SECOND: Article III of the Articles of Incorporation of the Corporation is amended, in its entirety, to read as follows:

#### "ARTICLE III - PURPOSE

This Corporation is being organized for the purpose of restaurant ownership and management and any lawful purpose permitted under Florida law."
