Present was John C. Stovall, sole shareholder, officer and director, who waived notice of the meeting by his attendance and his signature on these minutes

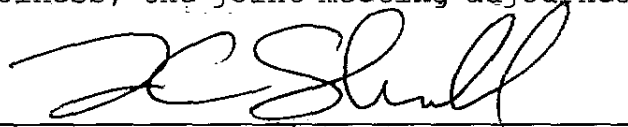
The meeting convened and the following actions were taken.

(1) Waived the reading of the minutes of the organizational meeting and the first meeting of the Board of Directors.

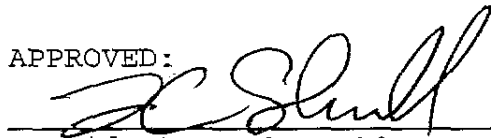

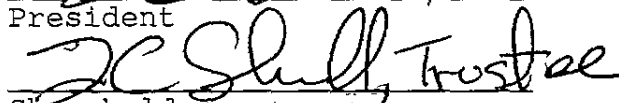
