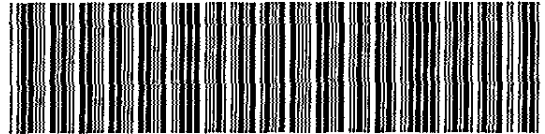

ARTICLES OF INCORPORATION

The undersigned, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, pursuant to Chapter 607, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

ARTICLE I

Culinary Outfitters, Inc.

The name of this corporation shall be, **Culinary Outfitters, Inc.**, 11 South Dixie Highway, Unit 9D & 9E, St. Augustine, St. Johns County, Florida 32084, (904) 829-2727.

ARTICLE II

DURATION

This corporation shall have a perpetual existence unless sooner dissolved according to law. Upon dissolution of the corporation all assets of the corporation, including real property and bank accounts, shall be given to: **Culinary Outfitters, Inc.**, 3304 Shore Drive, St. Augustine, Florida 32086, (904) 829-2727. This is the actual mailing address for this corporation.

ARTICLE III

PURPOSE

The purpose of this corporation is to conduct the business of retail sales of food, food products, and catering (food) both on site and off-site under the Florida General Corporation Act.

ARTICLE IV

DIRECTOR

ARTICLE V

OFFICERS

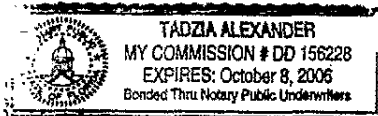




