ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Buşiñess Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

Article 3. Duration. The duration of the Corporation is perpetual.
