ARTICLES OF INCORPORATION

OF

THE JOHN CAMPBELL AGENCY, INC.

ARTICLE I

The name of the corporation is The John Campbell Agency, Inc., (the "Corporation").

ARTICLE II

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.

The Corporation shall hold a special meeting of shareholders only:
