



ARTICLES OF INCORPORATION OF NORTH FLORIDA PAVERS, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

Article I - Name

The name of this corporation is NORTH FLORIDA PAVERS, INC.

Article II - Duration

This corporation shall have perpetual existence.
