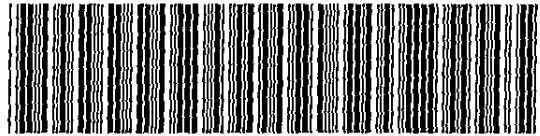

**ARTICLES OF INCORPORATION  
OF

***ARTICLE I. NAME***

The name of the corporation is:





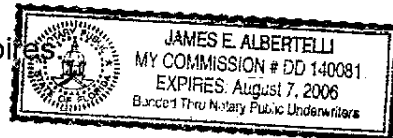
