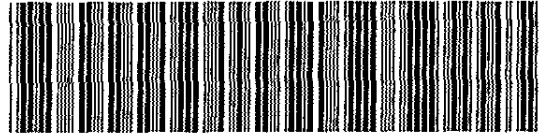

ARTICLE I - NAME

The name of this corporation is FLORIDA NU-TURF, INC.,
and its principal office and mailing address is:

ARTICLE II - DURATION

This corporation shall exist perpetually.

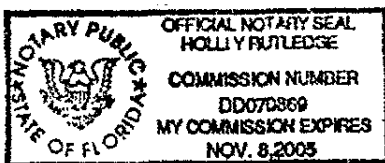

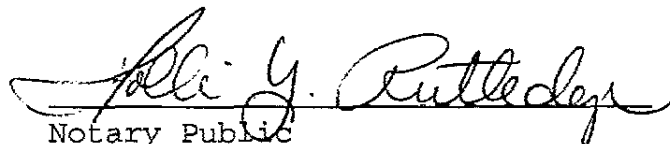
